The Church, through its leaders, hereby certifies as follows:

- Before the date of the Event, the Church shall conduct criminal background checks on all of its adult (age 18 or over) participants attending the Event (the "Church's Adult Participants").
- All background checks on the Church's Adult Participants have been conducted within the past two (2) years.
- The Church's Adult Participants have been known to the Church for at least six (6) months and approved to work with minors (those under 18) in the Church's setting.
- All of the Church's Adult Participants have signed and submitted to the Church the Assumption of Risk and Waiver / Release of Liability provided to the Church by KBC (the "Adult Waiver").
- The Church is bringing minors to the Event.
- All of the Church's minors have submitted to the Church a KBC Assumption of Risk and Waiver / Release of Liability signed by the minor's parent or guardian (the "Minor Waiver").
- It is the Church's responsibility to safeguard and maintain signed copies of the Adult Waivers and the Minor Waivers for each of the Church's participants for a period of at least five (5) years.
- The individuals signing below have the power and authority to sign this Certification on the Church's behalf.

Indemnification and Waiver: The Church agrees to indemnify, hold harmless and defend KBC from and against all claims asserted against KBC, its agents and/or employees, arising from the Event, and/or any negligent, gross negligence or intentional act or omission of the Church, its employees, agents, officers, directors and/or volunteers in connection with the Church's participants participating in the Event. KBC agrees to indemnify, hold harmless and defend the Church, its employees and/or agents from any claim arising from any negligent, gross negligence or intentional act or omission of KBC, its agents and/or employees in connection with the Event.
